

Rules for Sport fishing Hårkankortet

Hårkankortet

Terms and conditions:

- ✓ NOTE! The card refers to fishing only in the Hårkans water system and not in other waters belonging to the above fishery conservation areas
- ✓ Fishermen should be aware of applicable laws and regulations and by the Fish Management Association (FVO) issued special rules
- ✓ Violation of the provisions stated entails confiscation of the fishing right and may lead to claims for control fees or prosecution
- ✓ Fishing is only allowed with sport fishing, a maximum of one rod brought from hand per person, thus not longline, hook or yarn capable tools
- ✓ The fishing permit is personal and not transferable to another person
- ✓ The fishing permit shall be kept on the fishing operation and be presented on request from the Fishing Supervisor
- ✓ Fishing from boat is not allowed in flowing water
- ✓ Driving on existing roads in the wilderness in the area at own risk
- ✓ PLEASE TAKE CARE OF THE ENVIRONMENT, TAKE YOUR GARBAGE BACK HOME AND EXTINGISH MADE FIRES

Valsjöns Fish Management Association (FVO)

Waters included:

Rengen (from the Swedish border) - Minimum size trout 35 cm, fishing from boat is allowed
Rengströmmen - open 1/11-31/8

Valsjön - Minimum size trout and grayling 40 cm, fishing from boat is allowed

Toskströmmen - open 1/6-31/8, minimum size trout and grayling 40 cm, fishing with live bait is prohibited (angling with worm), bag-limit 1 fish/person and day. 1/7-31/7 only open for fly fishing. Fishing is prohibited upstream the bridge

Stor-Gruveln - Minimum size trout and grayling 35 cm, fishing from boat is allowed

Part of Hotagssjön - fishing from boat is allowed

Other general conditions:

Minimum size trout and grayling 25 cm unless otherwise stated

Bag-limit max 5 trout/person and day

Fishing with live bait is prohibited

Free fishing for children and adolescents under 18 years

Föllinge Kyrkslätt Fish Management Association (FVO)

Waters included:

Lövsjön

Lövsjöströmmen – fishing with bait is prohibited, minimum size trout and grayling 40 cm, bag-limit maximum 3 fishes/person and day of trout or grayling over minimum size can be retained, all trout and grayling below the minimum size shall be put back irrespective of the condition of the fish, fishing for trout in Lövsjöströmmen is prohibited during 1/9 - 31/5

Other general conditions:

Fishing for trout in streams is prohibited during 1/9 - 31/5

Free fishing for children and adolescents up to the age of 16 only in the company with a parent who holds a valid fishing license (at his quota).

Sandviksjön Edsforsens Fish Management Association (FVO)

Waters included:

Näsaforsen

Sandviksjön

Edsforsen - the eastern furrow of Edsforsen prohibited downstream of the northern tip of Storön

Baksjön – maximum 5 fishes/person and day of trout or grayling, boat, canoe and float tube is prohibited, prohibited from fishing from 1/10 to the fishing premiere in februari

Hårkan

Streaming water:

Maximum 5 fishes/person and day. Minimum size 35 cm. Maximum of one rod brought from hand per person, with a maximum of three hooks

Fishing is prohibited 1/9 - 31/5 (except for fishing with fly for grayling during September)

Nedre Hårkans Fish Management Association (FVO)

Waters included:

Hårkan

Fishing is allowed 1/6-1/9, only fishing for grayling 1/9-30/9

Fishing for grayling is prohibited 1/5-30/5, fishing for trout is prohibited 1/9-1/6

Minimum size trout and grayling 30 cm and a maximum of 5 fishes/person and day.

Maximum of one rod brought from hand per person, with a maximum of three hooks

Litsbygdens Fish Management Association (FVO)

Waters included:

Hårkan

Minimum size for trout and grayling 30 cm

Fishing for trout in Hårkan is prohibited 1/9 - 31/10

All fishing prohibited 50 m downstream from the power station dam in Högfors

Free fishing for children under the age of 16 only in the company with a parent who holds a valid fishing license
